2. IN WHAT WAYS DOES YOUR CONGREGATION "SEND PERSONS INTO THE WORLD TO LIVE LOVINGLY AND JUSTLY AS SERVANTS OF CHRIST BY HEALING THE SICK, FEEDING THE HUNGRY, CARING FOR THE STRANGER, FREEING THE OPPRESSED, BEING AND BECOMING A COMPASSIONATE, CARING PRESENCE, AND WORKING TO DEVELOP SOCIAL STRUCTURES THAT ARE CONSISTENT WITH THE GOSPEL

At Palisades UMC, we strive to be God's hands and feet in this world. Over the past year, we have continued our outreach with FAM providing food, clothing, school supplies and other amenities to those in need. During our stewardship campaign we partnered with Rise Against Hunger and made over 10,000 meals for a community in South East Asia. Every year during Advent, we partner with the Gilchrist House providing Christmas gifts for the children living there. We usually provide Christmas gifts for 30 families. This year we also parentered with the local assisted living, Villas of San Clemente. We started a small group that has turned into a weekly bible study for those who don't have a church to call home. We have on average 8-12 people a week who come to this gathering.

3. IN WHAT WAYS DOES YOUR CONGREGATION "CONTINUE THE MISSION OF SEEKING, WELCOMING AND GATHERING PERSONS INTO THE COMMUNITY OF THE BODY OF CHRIST"?

At Palisades UMC, we strive to be a welcoming community that invites people into the community of the body of Christ. This year, we have reached new individuals from our local assisted living who regularly come to worship with us. Sadly, over the past 3 months it has been difficult for these individual to come to our church service as the organizations bus driver is no longer there. We have some members who pick up some of these individuals but at times it is hard. God has blessed us with new families and couples who have found our church and are calling it home. We continue to provide opportunities for new people to call our church home through easy "on-ramp events." With our outreach program with Rise Against Hunger we were also able to partner with a local girl scout troop and 4-5 families showed up to help us out. From this we now have a few more people coming to our 2nd annual Woman's Christmas Tea event. Last year we had close to 80 women there and we are expecting the same number. Finally, we continue to seek and welcome those in our community who cannot be in worship through our online services/sermons.

4. NARRATIVE REPORT OF THE PASTOR:

1) The importance of community in our personal lives and the church's life. We were created to be in a community, be with one another, and support one another during the good times and challenging times. We have helped those in need in our congregation and those in our community as a church. We have provided food for the local food bank, Christmas gifts for children, and meals for those less fortunate and so much more. We have been focusing on gathering together as a community more frequently, let it be at a restaurant or a potluck after church. We are also focusing growing spiritually as a church with our monthly prayer meetings on the third Saturday of each month. Even though we have a handful of people, each person who comes describes the joy and peace they experience after are time in prayer. We also started a new internship with our choir for students who are seeking to be a choral director or major in music. We currently have two people who are in this year-long pilot internship. We are also growing and fostering our relationship with the Villas which is extremely fruit with 8-12 people coming a week.
